LEAK CHECK POLICY

It is the policy of Farmers Union Oil Company and our insurance company, that a leak check shall be performed if any of the following conditions apply:

- 1) Customer is out of propane gas.
- 2) Customer is new to our company or another propane company has filled the tank.
- 3) Any change in ownership (or tenant if a rental).
- 4) If any changes have been made to the system. (A new propane appliance for example)

Customer will be charged \$50.00 to complete a leak check.

The most common procedure will be a test between the first stage regulator and the second stage regulator for three minutes. Someone over 18 years of age must be present so we can access all propane appliances and turn off the service valves to perform the leak check. A pressure decrease indicates a leak in the system.

If a customer runs out of gas after hours, there is a \$100 after hours fee that will be charged in addition to the \$50 leak check. There is a minimum 200 gallons.

With winter coming, please be sure to have a path cleared to your propane tank otherwise we may not be able to deliver.

We ask that you please call 3-4 days in advance when ordering propane.

CREDIT POLICY

Before anyone is allowed to charge, they must complete a credit application and meet our credit policy requirements. Management may limit the amount of credit given to any individual or company.

Credit or debit cards used to pay account balances will be subject to a 2.5% processing fee. Credit or debit cards cannot be used to pay balances that include agronomy purchases (seed, fertilizer, crop protection, etc). If you are 30 days past due, credit on all products and services will be discontinued immediately. All purchases must be paid in full in this case. Our accounting system automatically locks the account when it reaches this point when no payment has been made.

Collection proceedings will begin after 90 days past due if you have not made payment arrangements with the management team.

A finance charge of 1.5% per month (ARP of 18%) will be charged on any account over 30 days past due. You will be sent reminders that your account is past due.

Past due accounts must be paid before the next bulk gas or propane fuel delivery will be made. Minimum deliveries for bulk fuel, gas & LP are 200 gallons or a fill. There will be a \$50 delivery fee for under 200 gallons. Propane deliveries that are after hours will be charged a \$100 emergency fee plus any other applicable charges (i.e leak check fee).

Agricultural supplier's lien will be filed on accounts past 90 days or as needed for agronomy purchases in accordance with the ND Century Code 35-31-01.

Accounts that are continuously delinquent and past due 90 days will be put on a cash basis indefinitely. Charging privileges will be revoked.

Cash accounts must pay in full prior to delivery.

Fuel assistance customers that don't have an open charge account must have their percentage paid in full before delivery. This cannot be charged.

If you rent/lease your propane tank from Beulah Cenex you must purchase all of your propane from Beulah Cenex. Beulah Cenex and its employees will not be held responsible for regular scheduled propane deliveries (keep full) if the patrons account is past due!

Management reserves the right to refuse or limit credit privileges to anyone, at any time, based on ability to pay, financial conditions and or previous experience.
